*Where to Send Requests for Data*

You may ask to view, or request paper copies of data including documents, emails, and databases from the Minnesota Department of Public Safety (DPS). Also, you may obtain data on audio tapes, video tapes, and in other formats.

A contact person in each DPS division is designated to ensure that data is handled legally. It is not legal for government agencies to ask those who request data who they are or why they want it.
